4. Pre-bid meeting shall be held at Sajha Yatayat Office on mentioned date, and time respectively.
5. Interested Bidders shall submit the electronic Bids through [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) to the above office of Sajha Yatayat on or before 12:00 hours on 10 January 2024.
6. Bids shall be opened in presence of Bidders' representatives who choose to attend at above mentioned respective time and date at the office of Sajha Yatayat. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by a minimum mentioned bid security amount, which shall be valid for minimum 30 days beyond the bid validity period.
7. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
